
Adopted Departmental Budget in Brief: Environmental Health





Department Mission

The Environmental Health endeavors to promote and protect public health and preserve the environment by conducting activities to prevent disease, educate the public, establish partnerships and enforce regulations. Environmental Health includes programs administered pursuant to Chapter 130A of the General Statutes of North Carolina.

Department Services Provided

Three primary programs operate within Environmental Health:

- Food, Lodging and Institutions Program (FLI)
- Children's Environmental Health Program (CEH)
- On-Site Water Protection Program (OSWP)

The OSWP Program serves the community through the protection of surface and ground water supplies. The FLI Program conducts plan review, permitting and inspections of businesses that prepare and serve food or operate pools, institutions or lodging establishments. The CEH Program endeavors to protect and improve the health of children by conducting regulatory activities associated with child lead poisoning prevention, child care facilities, schools and camps.

Department FY 2020 Discussion

Continued growth in residential development will increase the number of food establishments, child care facilities, schools, and public pools requiring inspections along with continued demand for on-site systems and wells. Beyond the growth, weather impacts, specifically flood water and ground water quality concerns are driving an increase in well water sampling demand. In addition, Legislative changes will affect OSWP and CEH (child blood lead levels) and new on-site wastewater rules. The emerging public health trends such as housing complaints such as mold and bed bugs, mosquito issues, solid waste complaints, foodborne illness cases, food recalls, well water contamination concerns, etc., are dynamically changing the service demands for Environmental Health.

Department Analysis

The FY20 adopted budget includes \$98,964 to fund one additional Health Program Specialist for the Food, Lodging and Institutions Program (FLI) as well as an additional Health Specialist for the Children's Environmental Health (CEH) Program (\$92,507).
