

**RESOLUTION OF THE UNION COUNTY WATER AND SEWER DISTRICT  
BOARD OF GOVERNORS FOR AMENDMENT TO THE UNION COUNTY WATER  
AND SEWER DISTRICT RATE AND FEE SCHEDULE RELATED TO SYSTEM  
DEVELOPMENT FEES**

WHEREAS, the Union County Water and Sewer District (the "District") Board of Governors (the "Board") adopted the Union County Water and Sewer District Rate and Fee Schedule ("Rate and Fee Plan"); and

WHEREAS, the current Rate and Fee Plan is effective for District Fiscal Years 2018-2020; and

WHEREAS, the Rate and Fee Plan includes water and sewer system development fees charged to certain new development connections; and

WHEREAS, as part of the calculation and consideration of the adoption of system development fees a professional written supporting analysis was conducted that calculated appropriate system development fee amounts; and

WHEREAS, the Board adopted this supporting analysis; and

WHEREAS, the Board desires to adopt an amendment to the Rate and Fee Plan which amends the system development fees within the amounts allowed by the supporting analysis.

NOW, THEREFORE, BE IT RESOLVED BY THE UNION COUNTY WATER AND SEWER DISTRICT BOARD OF GOVERNORS AS FOLLOWS:

1. The amendment to the Union County Water and Sewer District Rate and Fee Schedule, attached hereto as Exhibit A, is hereby adopted.
2. This Resolution is effective February 1, 2020.

## EXHIBIT A

### AMENDMENT TO THE UNION COUNTY WATER AND SEWER DISTRICT RATE AND FEE SCHEDULE

The Union County Water and Sewer District Rate and Fee Schedule (the "Rate and Fee Schedule") shall be amended as follows:

1. Replace the existing table (along with the corresponding note) in Section 3(A), Water System Development Fees (Formerly Designated Water Capacity Fees), with the following:

Fire Connection	NO FEE

2. Replace the existing table (along with the corresponding note) in Section 3(B), Sewer System Development Fees (Formerly Designated Sewer Capacity Fees), with the following:

1 1/2"	\$14,000
2"	\$22,400
3"	\$42,100
4"	\$70,100
6"	\$140,300
Fire Connection	NO FEE
