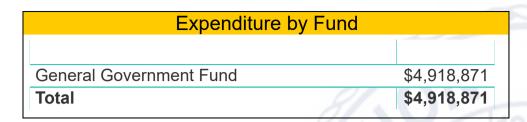

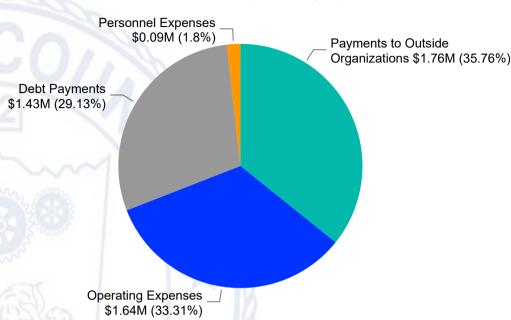

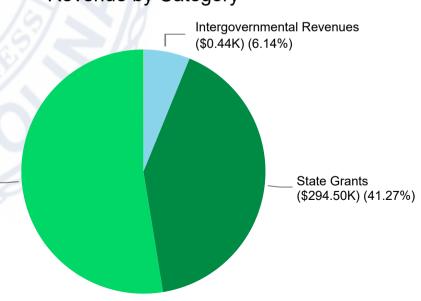
#### **Expenditure by Category**

#### **Department Analysis**

State grant revenue remained flat in FY 2020, fully funding the County's North Carolina Department of Public Safety Juvenile Crime Prevention Council Program (JCPC).

In FY 2020, the adopted budget reduces support to Outside Agencies by \$151,768, or 3.0 percent. This is based on a decrease of debt service payments for the Judicial Center of \$64,942. There is one County position (1.0 FTE) assigned to the DWI Treatment Court Program. DWI Treatment Court Program is recommended to receive an additional \$15,000 in FY 2020 to provide additional treatment services. The District Attorney's Office received an increase from FY 2019 funding totaling \$3,518 and the Jury Selection Program received an increase totaling \$648. The BOCC maintain the FY 2020 funding for remaining Outside Agencies stable at FY 2019 funding levels.
