Submitters on this project are hereby notified that this Addendum shall be made a part of the above named RFQ document.

The following items add to, modify, and/or clarify the RFQ documents and shall have the full force and effect of the original documents. This Addendum shall be acknowledged by the offeror in the RFQ document.

A) **Questions and Answers**

1. Question: We would like to develop two graphics that would be more conducive on a 11x17 page layout. Is this acceptable?

Answer: 11 x 17 pages for special graphics shall be acceptable. These pages do count toward the page count limit.

2. Question: We agree with a minimum font size of 11 point for text; however, we have been allowed in the past to use 9 point font size for graphics, captions, and tables. Is this acceptable?

Answer: The minimum font size of 11 point does not apply to graphics, captions, or tables.

3. Question: Is it possible to include 11" x 17" paper within our proposal for figures and/or graphics?

Answer: 11×17 pages shall be acceptable for special graphics and these pages do count toward the page limit.

4. Question: We would like to request the historical daily average data that was used to develop the values provided in Table 2 (Influent flow, CBOD5, TSS, NH3, and TP) and Table 3 (CBOD5, TSS, NH3, TP) in the RFQ from June 2019 -May 2021. For the same time period, we would also like to request the aeration basin MLSS and SVI and the final effluent pH, DO, and temperature.

Answer: We will not be providing this information for the RFQ due to limited resources to compile all of the requested information. This information is not necessary to be able to submit an SOQ for this RFQ. This data can be provided during design of the project once an engineering firm has been selected.
