Below are changes, additions, and/or clarifications to the bid documents for this project.

Q/A & Clarifications

<u>Item 1</u>: Question: Note 2 on sheet C-02 and C-03 states the below:

"See sheet C-04 for Charlotte Water standard detail "12-inch FMCT water meter and precast concrete vault service connection. Furnish and install all components as shown in the detail unless otherwise called for in the plans."

The 12-inch FMCT detail shows components that are not shown on the octave meter vault detail such as a 2" bypass line with 2" meter and a 12" check valve. Will these be required to be installed?

Answer: Yes, items shown inside the vault in Charlotte-Mecklenburg Utilities - Detail Q on Sheet C-04 of the construction plans are required to be installed, including a 2" bypass line with 2" meter and 12" check valve, among other items. There are items outside the vault that are not required and are not shown on Sheets C-02 and C-03 of the plans to be installed, including Item No. 1 – 12" Tapping Sleeve & Valve; Item No. 4 – 12" Adapter/12" Gate Valve; Item No. 18 – 2" Temporary Blow Off; Item No. 23 – Minimum of Three Concrete Brick Courses Under Access Door Frame.
