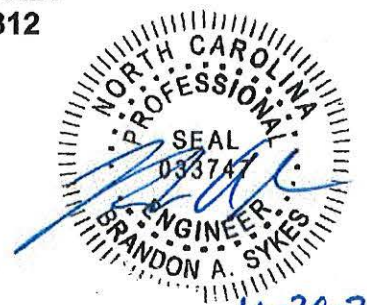

Sealed Bids for the construction of project **Twelve Mile Interceptor I/I Abatement Project** will be received by Union County Procurement Department, Union County Government Center, at 500 N. Main Street, Suite 709, Monroe, North Carolina 28112, until **2:00 PM** local time on **\*May 25, 2021** at which time the Bids received will be **publicly** opened and read. The public bid opening will be conducted outdoors, in the front entrance area of the Union County Government Center address listed above at the specified date and time. ***If you plan to attend the bid opening, face masks and social distancing rules apply.***

\*On **May 25, 2021**, beginning at **1:30 PM** local time, bids will be received by the Union County Procurement Department at the bid opening location of Union County Government Center, 500 North Main Street, in the front entrance area of the Union County Government Center, Monroe, NC 28112.

**Project consist of the following items:**

- **Test and seal grouting of approximately 12 EA pipe joints in 42-inch Reinforced Concrete Pipe**
- **Installation of 3 EA 42-inch CIPP Sectional Liners**
- **Miscellaneous manhole leak injection and repair**
- **Access improvements and site restoration**

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, with additive alternate bid items as indicated in the Bid Form.

Prospective Bidders may examine the Bidding Documents at the Issuing Office or at the Union County Procurement Department offices at 500 North Main Street, 7<sup>th</sup> Floor, Suite 709, Monroe, North Carolina 28112 on Mondays through Fridays between the hours of 8:00 am and 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Checks for Bidding Documents shall be payable to "**Hydrostructures**". Cost of Bidding Documents includes ground shipping. Upon request and receipt of the document deposit indicated above, the issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

If Bidding Documents are required to be shipped overnight, Bidder shall provide a six-digit UPS account number. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents.

Bidders must have a license to do work as a general contractor in the State of North Carolina, as set forth under Article 1 of Chapter 87 of the North Carolina General Statutes. The Contractor's North Carolina License number shall be designated on the outside of the envelope containing the bid.

Bidders are required to comply with the non-collusion requirements set forth in the Bidding Documents.

Bid security shall be furnished in accordance with the Instructions to Bidders. Union County (Owner) reserves the right to reject any or all bids.

Union County encourages good faith effort outreach to Minority Businesses (HUB Certified) and Small Businesses.
