4. Detail on where new wall will start

Answer: The new wall will go to the bottom of the bulkhead as shown on Attachment 2 of this addendum.

6. Carpet repair/allowance if needed at wall and door removal.

Answer: Allow \$1,500.00 as a general unforeseen allowance. Please see Attachment 1, revised Price Page, of this addendum

7. Will existing counter be repurposed.

Answer: Contractor shall carefully remove the counter and turn over to UC.

8. Is there any flooring in the Monroe 6th floor remodel?

Answer: Just carpet repair where wall is to be removed. Information about the carpet will be made available to the successful contractor.

9. Any Labor requirements?

Answer: Follow NC State Statutes for Labor requirements.


