A) Delete/Replace/Add

1) SECTION 2 – Notice of Advertisement, Page Number 4, 1st & 2nd paragraphs

DELETE: "Sealed bids, so marked, will be received by mail or hand delivery to Union County's Procurement Department until 2:00 PM (local time) on March 25, 2021 at the Union County Government Center, 500 North Main Street, Monroe, NC 28112. The public bid opening will be conducted outdoors, in the front entrance area of the Union County Government Center at the specified bid date and time. Late bids will not be accepted. If you plan to attend the bid opening, social distancing rules apply.

*On March 25, 2021 beginning at 1:30 PM local time, bids will be received by the Union County Procurement Department at the bid opening location, outdoors in the front entrance area of the Union County Government Center at 500 North Main Street, Monroe, NC 28112."

<u>REPLACE with the following:</u> "Sealed bids, so marked, will be received by mail or hand delivery to Union County's Procurement Division until 2:00 PM (local time) on **March 31, 2021** at the Union County Government Center, Administrative Services, Procurement Division, 500 North Main Street, Suite #709, Monroe, NC 28112 at which time bids will be received. This is an informal bid. <u>A public bid opening is not required and will not be held for this project.</u>"

- 2) DELETE: All references to Performance and Payment Bonds throughout the bid document.
- 3) DELETE: All references to Due Date: March 25, 2021 at 2:00PM

REPLACE with the following: Due Date: March 31, 2021 at 2:00PM

B) **Questions and Answers**

1) Question: Will the fence require grounding?

Answer: No.

2) Question: The slide gates are manually operated in the spec. Will they have operators in the future? If so the tail of the cantilever gates will need to be covered in fabric to meet UL 325 standards.

Answer: Potentially, yes. Please include fabric on all tails.

3) In the scope of work section 6.1 you are asking for 6' Galvanized steel Black coat Commercial grade Chain link but in Section 6.1 A 1. It says the fabric is to be ASTM A-392 ClassII – zink coated steel. This is a galvanized product and can only be grey not black. Please confirm the fabric type needed. On the sycamore reservoir the spec we settled on was: 9-guage core 8-guage Finish, Class 2b fused and adhere black vinyl coated chain link fabric ASTM F668, 6' in height.

IFB 2021-054 Addendum #1 Event Center at Jesse Helms Park Fencing Project **Answer:** Fabric should be 9-guage core 8-guage Finish, Class 2b fused and adhere black vinyl coated chain link fabric ASTM F668, 6' in height – and respectively at dumpster enclosure 8' high fabric.

4) The Selvage treatment states Top: Knuckled Bottom: Twisted and Barbed. This appears to be backwards and I understood there would be no Barbed wire on the Project. Please confirm Selvage? Seeing that this will be around animals it would be more customary to due it this way Top: knuckled Bottom: knuckled

Answer: No barbed wire to be used, use instead selvage treatment, Top: knuckled, Bottom: knuckled.

5) In section 6.1 G1a. it states that Brace and rails to be Schedule 40, NPS 1-1/4 inch. This usually 1-5/8 inch. Please confirm what is needed.

Answer: Brace and Rails to be 1-5/8"
