Sealed Bids for the construction of the **Deese Pump Station Decommissioning** will be received by Union County Procurement Department, Union County Government Center* at 500 N. Main Street, Monroe, North Carolina 28112, until **2:00 PM** local time on **March 4th, 2021**, at which time the Bids received will be publicly opened and read. This public bid opening will be conducted outdoors, in the front entrance area of the Union County Government Center address listed above. *If you plan to attend the bid opening, social distancing rules apply.*

*On **March 4th, 2021**, beginning at **1:30 PM** local time, bids will be received by the Union County Procurement Department at the bid opening location, outdoors in the front entrance area of the Union County Government Center at 500 North main Street, Monroe, NC 28112.

The Project consists of **constructing approximately 1,200 linear feet of 8-inch sewer mains, 4 manholes, related appurtenances, and abandonment of existing Deese Ct pump station.**

Bids will be received for a single prime Contract. Bids shall be on a unit price basis.

Morehead St., Suite 300, Charlotte, NC 28208, Contact: Ben Koski at (704) 227 3426 or via email at bkoski@wkdickson.com.** Prospective Bidders may examine the Bidding Documents at the Issuing Office or at the Union County Procurement Department offices at 500 North Main Street, 7th Floor, Monroe, North Carolina 28112 on Mondays through Fridays between the hours of 8:00 am and 5:00 pm, and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents may be viewed and ordered online by going to Plan Room at www.wkdickson.com.

Following registration, complete sets of Bidding Documents may be downloaded as "zipped" portable document format (PDF) files. Printed hardcopies of the Bidding Documents can be ordered and shipped for an additional fee, which will depend on the number of sets, size of the Drawings, applicable taxes, and shipping method selected by the prospective Bidder. Costs of Bidding Documents and shipping are non-refundable, and are as follows:

Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.

Deadline for questions is 5pm on February 23rd, 2020. The Procurement representative will secure applicable answers from WK Dickson & Co., Inc. and/or Union County staff accordingly. If needed an addendum will be issued.

Bidders must have a license to do work as a general contractor in the State of North Carolina, as set forth under Article 1 of Chapter 87 of the North Carolina General Statutes. The Contractor's North Carolina License number shall be designated on the outside of the envelope containing the bid.

Bidders are required to comply with the non-collusion requirements set forth in the Bidding Documents.

Bid security shall be furnished in accordance with the Instructions to Bidders. Union County reserves the right to reject any or all bids.
