Calculating Schools' Tax Rate

- 1. Establish Penny Value for FY 2015
 - \$2,381,900 per penny of current Property and Motor Vehicle Tax
- 2. Establish the Current Expense Funding
 - \$89,876,401 is the UCPS Request Approved by the BOE on May 6, 2014.
- 3. Establish the UCPS Capital PayGo Funding
 - \$97,716,315 is the UCPS Request Approved by the BOE on May 6, 2014.
- 4. Add the UCPS Current Expense Funding and the UCPS Capital PayGo Funding together.
 - \$187,592,716 combined UCPS Request Approved by the BOE on May 6, 2014.
- 5. Divide Total Request by Penny Value and the result is the Requested Schools' Tax Rate.

The local impact of the Teacher Pay Increases and State Employee Pay Raises will be held by the County in reserve and based on the State's adoption of funding and will be released or reallocated.

The UCPS BOE identified an efficiency savings of \$500,000 in their request. To fully fund the remaining request would require \$2,949,242

Current Expense Funding Tasks

- 1. Provide UCPS the proposed level of current expense funding.
- 2. Request that UCPS provide a revised budget by function reflective of the proposed current expense funding.

Capital Funding Calculation

- Some legitimate needs included in the request.
- Past GO Debt Service tax increases would have been about 8.2 cents.
- Original discussions around the Facilities' Study focused on a \$20 million annual contribution.
 - Economic Downturn Occurred
 - Never Formally Approved by BOCC
- Funding for priority items.
- Ongoing funding structure that is sustainable and affordable.
 - Many items on list are not appropriate for Debt funding.
- Funding level should be determined by most pressing needs or a hierarchy.
 - Student Safety, Building Envelope, ADA Compliance, etc.

Capital Funding Tasks

- 1. Provide UCPS the proposed level of capital funding.
- 2. Request that UCPS provide a detailed project list at the proposed funding level.
 - Ideally a multi-year plan.
 - Staff can provide estimated revenue during the six-year window from FY 2015-2020.
