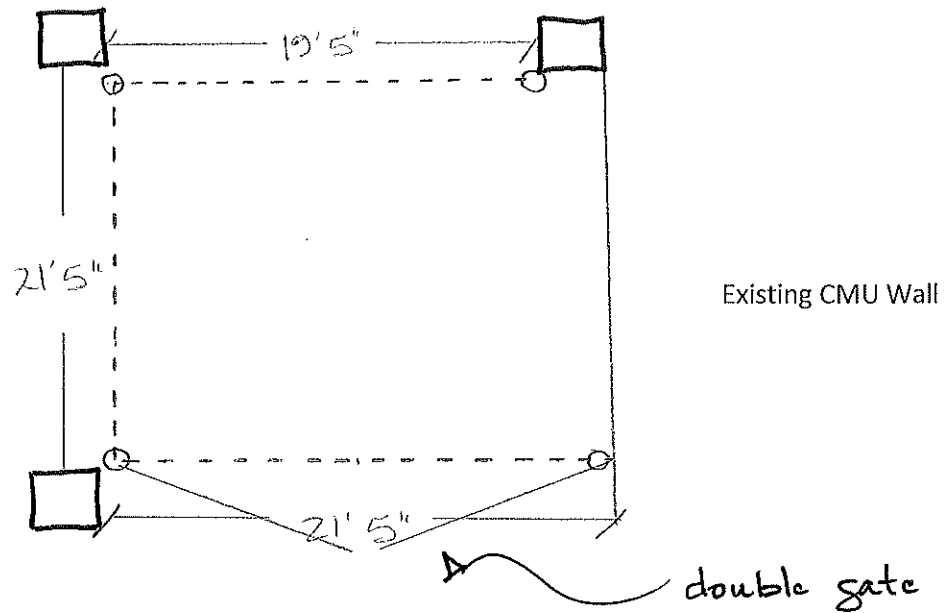

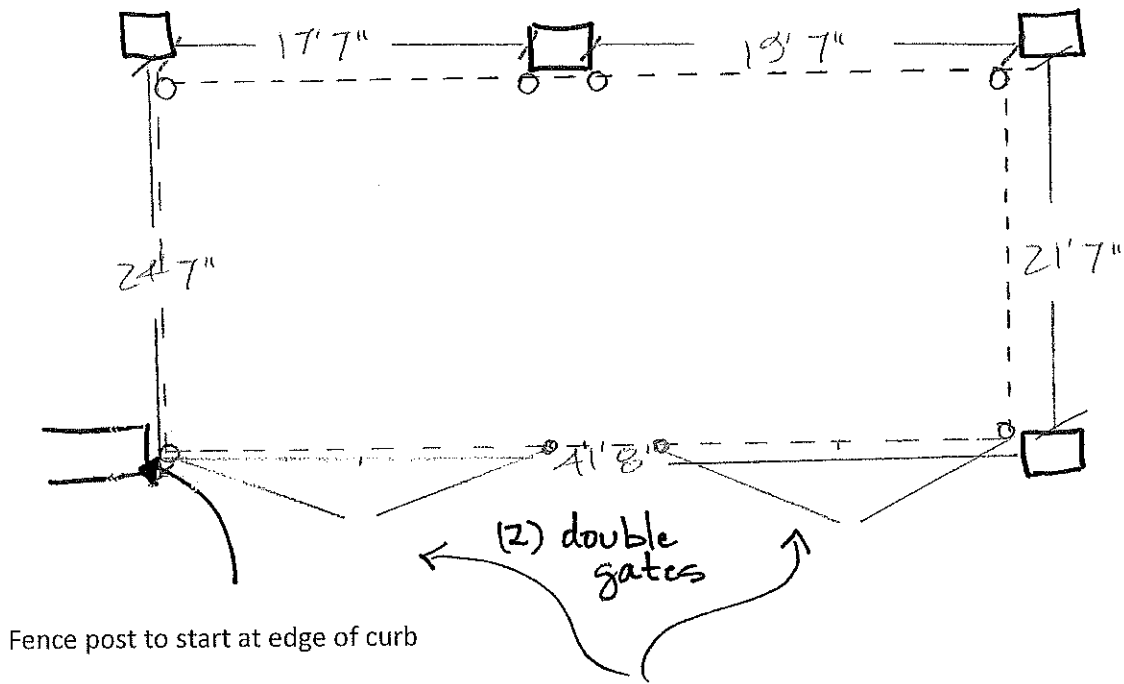
The Special Events Center at Jesse Helms Park - Chain Link Fencing Storage Area(s) Project

Storage Area #1 – Left Side of Arena Looking Out



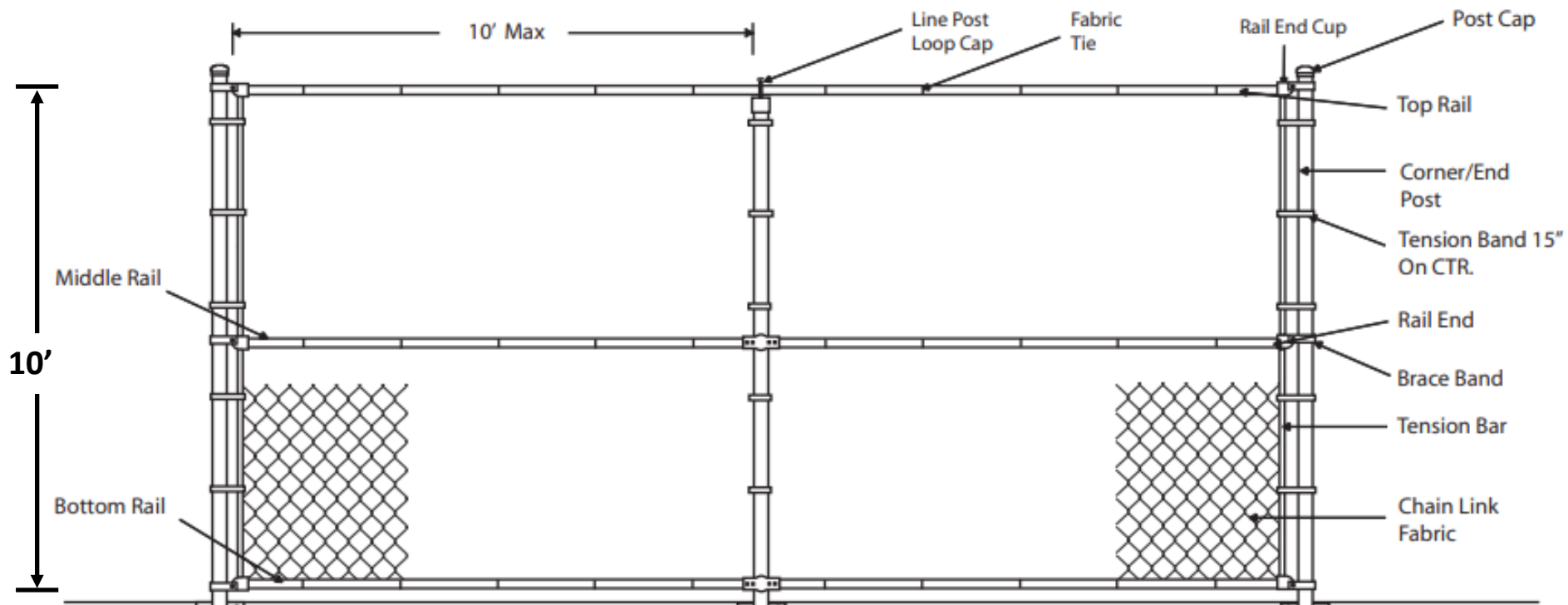

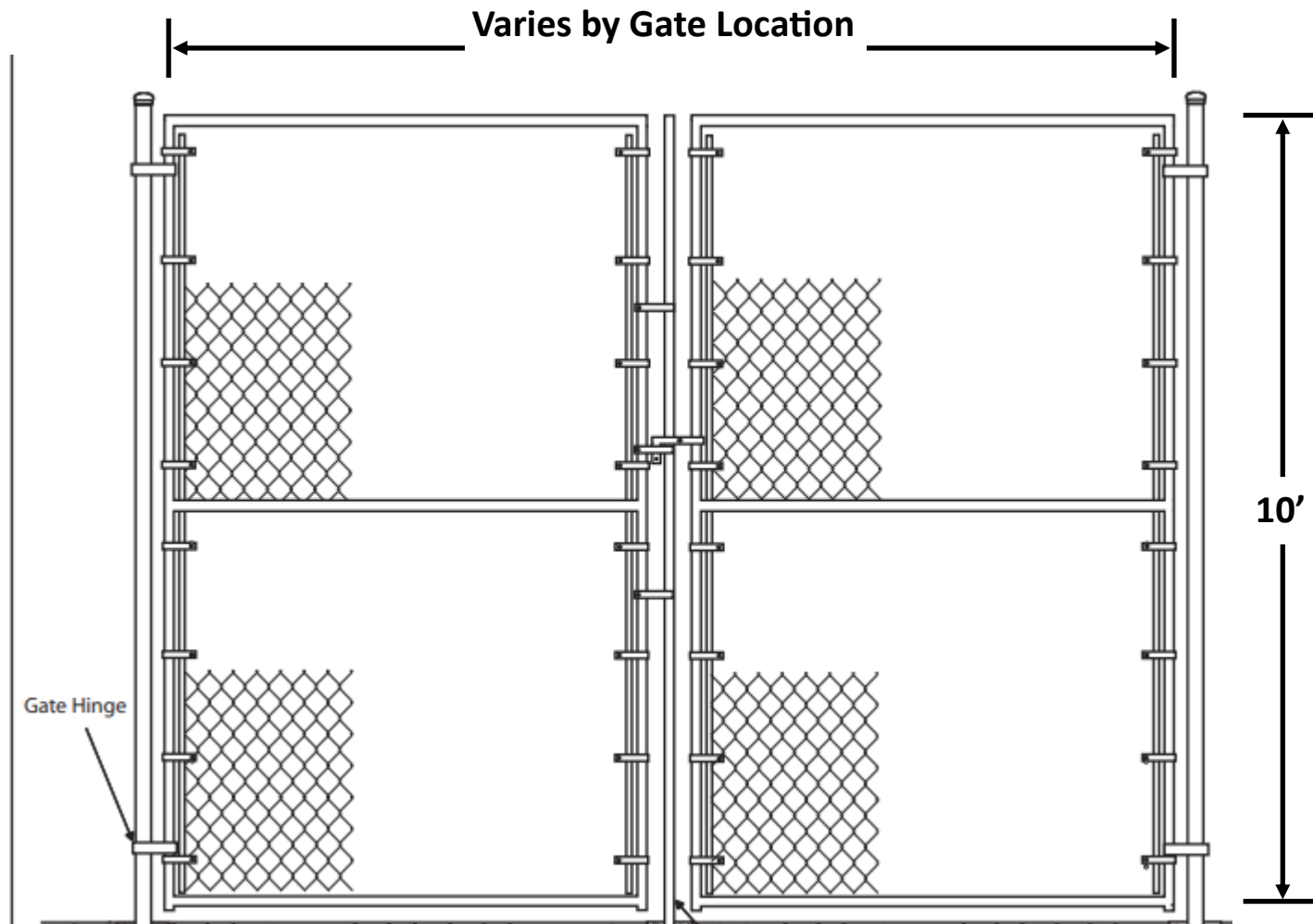

Storage Area #2 – Right Side of Arena Looking Out

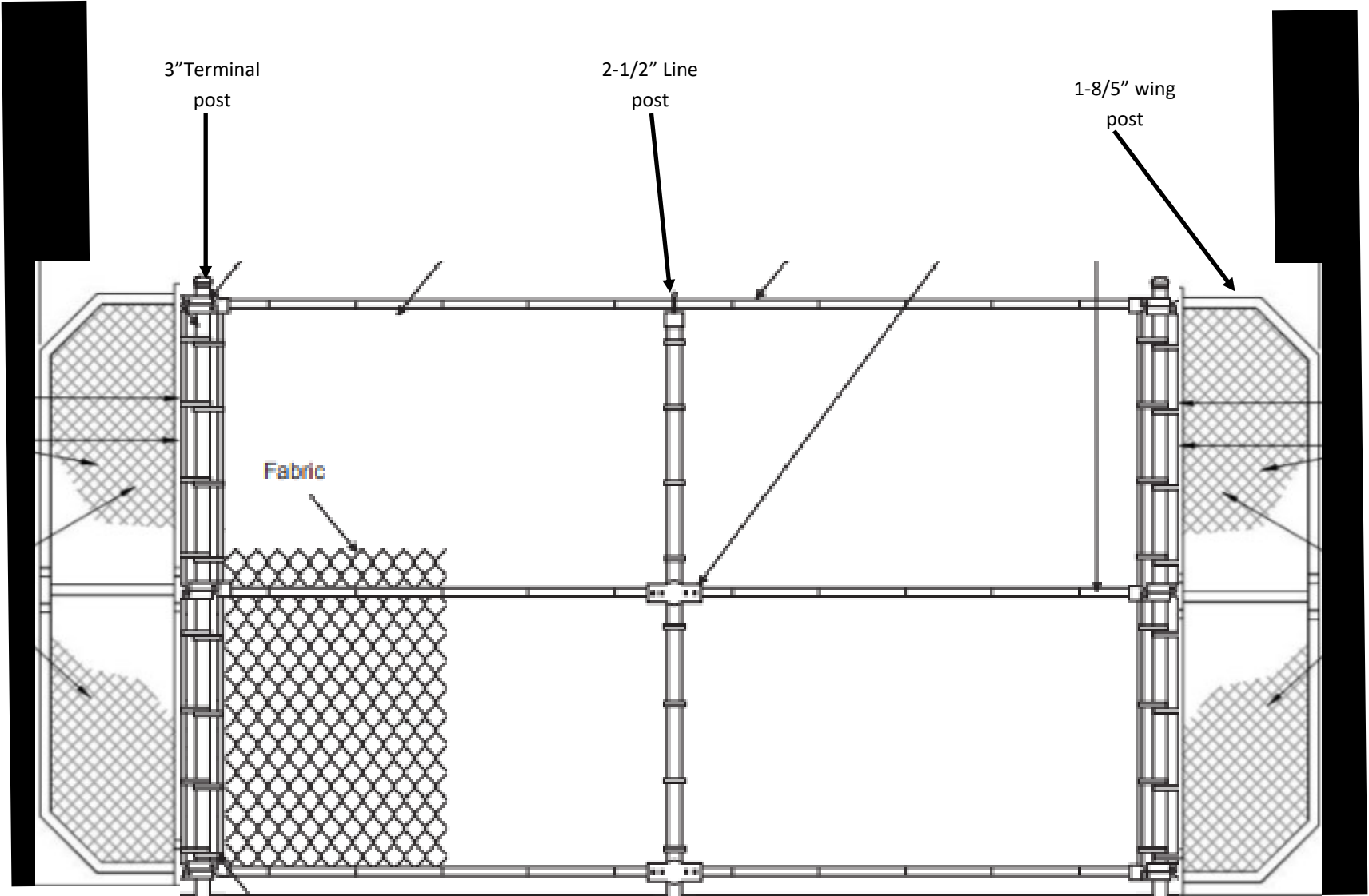
