Question/Answers

1. Can you describe the monthly monitoring requirement included in the proposal?

<u>Answer:</u> The monthly monitoring is a device that is wired into the generator and sends selected employees a text message or email when the generator starts/stops, fails to exercise, has any alarms, etc.

2. Do you already have a system in place for that?

<u>Answer:</u> We do have a plan in place with this through Kraft Power. I believe we own the monitoring devices and the actual monitoring is done through a company called Power Telematics. We don't deal with Power Telematics directly, Kraft Power handles that. When we need to remove or add someone to the monitoring list we contact Kraft Power and they coordinate with Power Telematics.

3. Can you give us the KW Kilowatt rating on all the generators on the equipment list?

Answer: Refer to Attachment A – Equipment List

4. Who currently has the contract?

Answer: Kraft Power

5. Progress Building says Manufacturer is Carrier. I have never heard of Carrier making a generator?

Answer: Yes it is a Carrier
