This project has received approval from the North Carolina Division of Environmental Quality Division of Water Infrastructure (NCDEQ, DWI) to utilize American Rescue Plan Act (ARPA) funding. Compliance with all reporting and documentation requirements in place at the time services are rendered will be required for this project.

This solicitation follows the Uniform Administrative Requirements, Cost Principals, and Audit Requirements for Federal awards (2 C.F.R. Part 200).Contracts resulting from this solicitation may be funded with federal grant funds which have been procured in a manner that is in compliant with all applicable Federal laws, policies, and standards as well as state law and local policies.
