- i) Support legislative efforts that protect and/or enhance local governments' revenues and/or increase local funding flexibility.

vii) Medicaid Expansion

With the potential for Medical Expansion, estimates indicate that Union County DSS will require 10 additional staff. Funding for these staff should be provided by the state, with funds also provided for office space and other required costs that are directly attributable to the expansion.

viii) Child Welfare

 Direct NCDHHS and LME/MCO's to develop and maintain placement options for all children who come into the custody of local departments of social services.

ix) Adult Entertainment Definition

 Establish drag queen performances as adult entertainment at adult establishments.

IV. UCPS Issues/Support

- School Calendar Flexibility/Local Authority
 - Allowing school districts to align their second semester with community colleges and universities does not require additional funding. We support school districts local authority to create school calendars that maximize student outcomes and best meet the needs of local communities.
- Financial System Implementation
 - The LEA Modernization project's complete implementation continues to be delayed and reporting capabilities are limited. Support the implementation be completed for the pilot LEA's.
- Charter School Accountability
 - Ability to verify student population data utilized for local payments.
