Scam letters have become increasingly prevalent, posing a significant threat to unsuspecting individuals. These deceptive communications aim to manipulate recipients into parting with their hard-earned money through various cunning tactics. However, armed with knowledge and awareness, you can protect yourself from falling victim to these fraudulent schemes.

This document provides valuable insights into the key elements of a scam letter that was recently sent to Union County residents. It will empower you to recognize the warning signs and make informed decisions to preserve your financial security.

- 1 **Logo** - This is not a logo associated with Union County.
- 2 **Terminology** - Union County calls this a Property Key.
- 3 **Creditor** - Union County does not collect taxes for the Internal Revenue Service.
- 4 **Phone Number** - This is not a local phone number. If you are ever skeptical you may verify the phone number listed on the Union County website.
- 5 **Hours** - Our hours are 8 a.m. - 5 p.m.
- 6 **Website** - This is not a Union County website.
- 7 **QR Codes** - When in doubt, never scan an unfamiliar QR code. They may lead to potential scams, malware, or unauthorized access to your personal information.

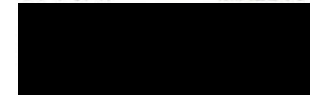

To avoid enforcement actions such as wage garnishment, seizure of property or assets, or levy, we strongly encourage you to contact 1(844)844-0562 by 6/9/2023. Please be aware that failure to respond may result in further collection actions being taken against the debtor.

As taxpayer, you have the right to retain licensed tax professionals or attorneys to assist you in understanding of your tax liabilities and rights. You are also entitled to the right of appeal in disputing balances, penalties, interest, or the ability to pay. It is the duty of the tax agency to provide you with such rights.

If any amount is credited against the tax liability for which the levy was imposed, other than the costs recovered, this communication shall not be construed as a bill. To dispute any further assessments, liens, or collection activities, please contact us at 1(844)844-0562.
