RE: Commitment to Hold Pricing Between Bid Date (July 27, 2023) and March 31, 2024

Regarding the above-referenced project and specified Rockwell Automation (RA) hardware and software in shown in the Construction Documents, RA shall commit to hold pricing to the RA-authorized distributor that is associated with the System Integrator that is awarded the project – for the duration of the time between the Bid Date (July 27, 2023) and March 31, 2024.

To further explain: Rockwell Automation sells its products and services through authorized distributors. Those distributors are independent businesses. Rockwell Automation cannot legally dictate re-sell pricing to any of its distributors. However, it is common for RA distributors to maintain the same re-sell price if/when the cost of that product or service remains the same. So, for this government-based project for the Municipality of Union County Water, Rockwell Automation can and shall commit to hold pricing to its affiliated distributors between the Bid Date (presumed to be July 27, 2023) and March 31, 2024.

The intent of this held pricing is to allow for time to review the bids, award the project, prepare early-release Submittals, review early-release Submittals, provide authorization of release of the hardware/software in question, and place an order for that hardware/software.
