1.7 This Addendum includes the following Questions and Answers:

a) What type of barrier is required for pedestrians?

Answer: cones and caution tape is adequate. Coordinating with the library will be essential.

b) Is the signage for redirecting pedestrians required by the contractor? Answer: the county will provide the appropriate signage.

c) What is the contractor laydown security? Answer: one Conex box will be allowed. The laydown area will approximately be 30' by 80'. Securing the area will be the responsibility of the contractor.

d) Are the columns required to be removed to install the metal panels on the B.o.E loading dock? Answer: it is at the discretion of the contractor to remove and re-install columns if necessary.

e) Is it acceptable to cut and caulk the panels to reinstall? Answer: this would require caulking at the top of the column.
