The following items add to, modify, and/or clarify the RFQ documents and shall have the full force and effect of the original Documents. This Addendum shall be acknowledged by the Offeror in the RFQ document.

Add/Delete Section

- 1. Delete: Section A Cover Letter, Bullet Point 3, "Prequalification with the NCDOT for relevant discipline codes, as defined by the firm."
- 2. Delete: 2.2 Submission Requirements, paragraph 1, "The maximum size accepted is 20 MB." Add: 2.2 Submission Requirements, paragraph 1, The maximum size accepted is 30 MB.

Question/Answer Section

1. Will there be a separate RFQ issued for commissioning services AND will Union County consider designer led commissioning or will 3rd party commissioning be required?

Answer: The County will engage a 3rd party commissioning agent for the project.

2. Does Union County have any sustainable design goals for this project?

Answer: The County will require the design to meet the requirements of a "High Performance Building" per NC DEQ.

3. How did you come up with 185,000 square feet? Was it some metric generated by the 600-bed count or a programming effort that generated the 185,000 square feet?

Answer: A programming master planning effort determined the 600-bed count and 185,000 GSF quantities.

4. Will an MWSBE utilization goal for design be established/ published prior to the execution of the Design Contract?

Answer: The MBE HUB goals will be captured and/or addressed in upcoming CMAR solicitation.

5. This type of building is very specialized and it's difficult to foster and train underutilized partners without jeopardizing the long-term security of the facility. We have been reaching out and are having some difficulty finding MWSBE partners with any jail experience. If we exercise good faith efforts and generate a low percentage of utilization will our good faith efforts need to be documented and/ or quantified and submitted In some fashion? If so is that a one-time thing or periodic reports?

Answer: For this RFQ, please refer to the last sentence on the Advertisement page, "Union County encourages good faith effort outreach to Minority Businesses (HUB Certified) and Small Business." You are not required to document or submit a report.

6. Would you publish/ distribute the list of participants in the Pre-Submittal Conference?

Answer: Yes. Please see Attachment 1.

7. Please confirm that the maximum submittal size has changed from 20 MB to 30 MB.

Answer: Yes. See Add/Delete Section, No. 2.

8. Who will Union County include on the Selection Committee? We are not asking for names and will not contact anyone. We are asking for roles within the County so we can tailor our submittal.

Answer: The County does not provide this information.

9. Does Union County have a Civil Engineer under contract for their assets or this site?

Answer: The County does not have a Civil engineer on contract assigned to specific assets or sites. The County expects that all responses to this RFQ would include a Civil Engineer as part of each design team.

10. How many other sites been identified for evaluation?

Answer: Two sites have been identified for consideration and other sites will be considered during the early design phase.

11. Can you share preliminary environmental concerns on the existing site (wetland delineation, soil bearing capacity issues, etc.)?

Answer: There are no certified environmental reports that can be shared for the existing site other than readily available FEMA flood plain designations.

12. Key Personnel resumes are included as an Appendix, can we identify this section as Appendix C?

Answer: Key Personnel resumes may be submitted in 6.2.3 Section C – Project Team or as a separate appendix to the SOQ.

13. Section 6.2.3 Section C- Project Team lists the items that are to be included for each team member as part of the detailed organization chart. This information is customarily included on individual resumes, which will be included in the Appendix. Can you elaborate on the expectation of Section 6.2.3? Will references made in this section back to the resumes in the Appendix be acceptable to the Selection Team?

Answer: The expectation is to follow the format in Section C. The resumes are for support only and not as a source reference.

14. 6.2.3 Section C – Project Team: The 7th bullet asks for Administration Capabilities: Is it the intent of the RFQ for our firm to describe our office administration, or our construction administration capabilities.

Answer; This bullet anticipates a response to overall "project administration" which may be inclusive of office, design and construction administration capabilities and personnel.

15. 6.2.1 Section A – Cover Letter, Bullet 3: Prequalification with the NCDOT for relevant discipline codes, as defined by the firm.
