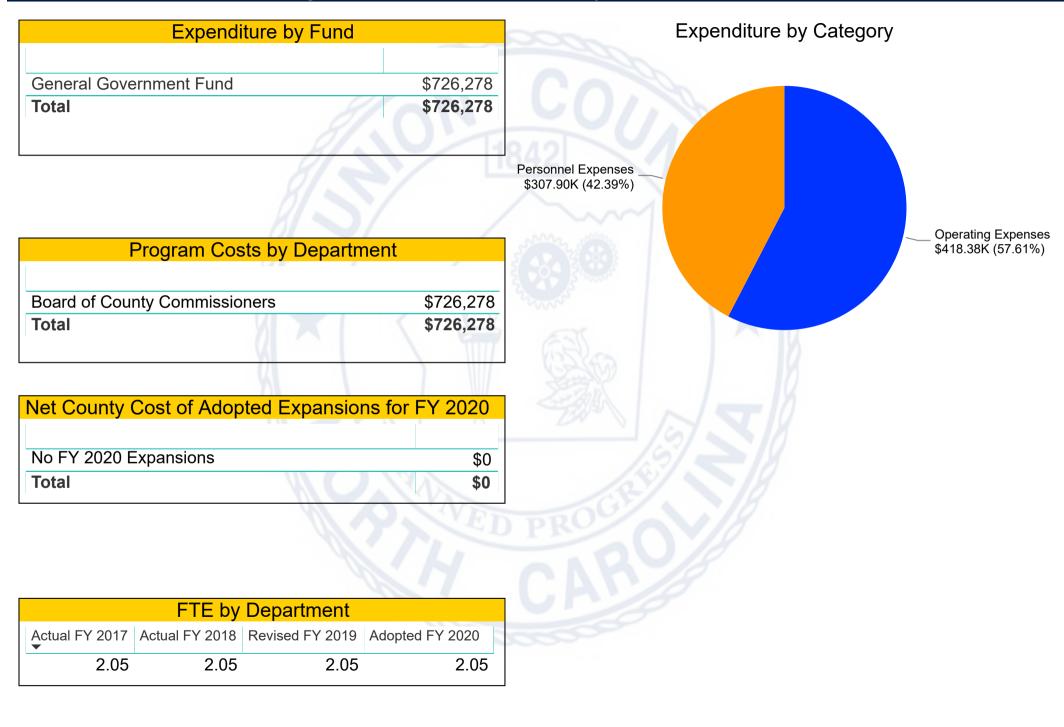
## Adopted Departmental Budget in Brief: Board of County Commissioners

## **Department Mission**

The Board of County Commissioners (BOCC) formulates policies that fulfill County government's responsibilities as identified in North Carolina Statutes, and the State Constitution, for the purpose of providing quality services to the citizens of Union County.

## **Department Services Provided**

The BOCC provides legislative and policy leadership to County Manager. It establishes policies for the operation of County government to provide services to the public in a cost effective, efficient manner and add value to the community. As the elected board, they communicate regularly with the public to insure County policies reflect the interests of the residents. As part of their role, Commissioners participate in community organizations, representing the County at all levels of the state.

## **Department Analysis**

The Board of County Commissioners office does not regularly produce revenue. The department is showing a \$93,359 (11.39 percent) decrease in total expense. The recommended reduction is a result of the elimination of recruitment services that was appropriated for county manager search. This decrease is in line with the two percent efficiency reduction as part of the FY 2020 budget process.
