#### 2.5 PROPOSAL ADDENDUM

Union County may modify the RFP prior to the date fixed for submission of proposals by the issuance of an addendum.

Should an Offeror find discrepancies or omissions in this RFP or any other documents provided by Union County, the Offeror should immediately notify the County of such potential discrepancy in writing via email as noted above.

Any addenda to these documents shall be issued in writing. No oral statements, explanations, or commitments by anyone shall be of effect unless incorporated in the written addenda. Receipt of Addenda shall be acknowledged by the Offeror on <u>Appendix</u> <u>B – Addendum and Anti-Collusion</u> form.

## 2.6 COMMUNICATION

All communications, any modifications, clarifications, amendments, questions, responses or any other matters related to this Request for Proposals must be made only through the Procurement Contact noted on the cover of this RFP. A violation of this provision is cause for the County to reject a Company's proposal. <u>No contact regarding this document with</u> <u>other County employees is permitted and may be grounds for disqualification.</u>

# **3 INTRODUCTION**

## 3.1 COUNTY

Union County (estimated population 257,000) is in the central, southern piedmont. The County provides its residents with a full array of services that include public safety, water/wastewater utilities and sanitation, human services, cultural and recreational activities, and general government administration.

Union County Water is a mid-sized, water and wastewater utility service provider to the unincorporated areas and most municipalities within Union County, North Carolina. We have a little over 180 employees dedicated to servicing approximately 58,000 customers. We own and operate two water treatment plants and five water reclamation sites and are solely funded by our rate payers.

# 3.2 PURPOSE

Union County Water is responsible for the upkeep and repair of all water infrastructure from the roadway to the water meter and all sewer infrastructure from the County-side sewer clean out to the roadway. The Warranty Program will provide residential property owners the opportunity to voluntarily purchase warranty coverage to repair the external private plumbing connecting a home to the water meter and/or sewer connection point, either typically at or near the road right of way.

The Program will operate separately from Union County's standard service offerings and will be billed independently. Program payments will not be added to Customers' water and/or sewer bills.

The selected company will enter into contract with Union County to allow them access to our customer information for marketing purposes and for the use of our logo for cobranding purposes. The selected company will have the opportunity to enter into a contract with residents via an agreement.

# 4 SCOPE OF WORK

Proposers are requested to provide the County with two (2) Proposal options:

• **Option 1** - Residential Water and Sewer Line Protection Program where monetary payment is provided back to the County based on the number of participants enrolled in the Program.

• **Option 2** - Residential Water and Sewer Line Protection Program that provides no monetary payment back to the County based on the number of participants enrolled in the Program but offers a lower monthly rate to participants enrolled in the Program. (County preference)

Repairs and materials must adhere to all applicable federal, state, local, environmental, health and safety regulations. All repair/replacement service(s) must follow code, applicable regulations, and ordinances. All permits are to be pulled by the Service Provider and/or subcontractor. In cases where the qualifying leak or failure occurs on a service line that is a galvanized or lead pipe, the plumber must replace that residential customer's water service line in its entirety with a material allowable for potable water by the applicable regulations and ordinances. The selected provider must provide repair or replacement of pressure reducing valves and sewer backwater valves for those customers who have them in place. Work completed must have a two-year warranty regardless of whether the resident remains in the program or not.

## 4.1 WATER AND SEWER LINE WARRANTY SERVICE PROGRAM OPTIONS

**A. Water Service Line Warranty Services**: The County is interested in selecting a Vendor to provide customer water service line protection which will repair or replace leaks or blockage to incoming water service lines. Qualifying leaks or failures should be repaired or replaced to good working conditions and within the building and plumbing code. The Warranty Plan should cover the cost of the investigation, repair and/or replacement of the service line from the residence to the County water meter. Coverage should include any site restoration including backfilling, raking, and reseeding/re-sodding; and/or replacement of concrete walkway and pavement and other improvements as necessary.

**B. Sewer Lateral Line Warranty Services**: The County is interested in selecting a Vendor to provide customer sewer lateral line protection to repair broken, damaged, or clogged sewer lateral pipes from the residence to the County side sewer cleanout. The Warranty Plan should include the cost of the investigation, site restoration including backfilling, raking and reseeding/re-sodding, and/or replacement of concrete walkway and pavement and other improvements as necessary. Repairs shall be completed compliant with building and plumbing code.

**C. Miscellaneous Warranty Services**: In addition to the above, Respondents should also propose other warranty programs/products and the proposed fees, charges and costs, separate from the Water and Sewer Line Warranty services that may be offered to County customers, including but not limited to warranty programs covering customer internal plumbing issues and appliances. It shall be up to the sole discretion of the County of which Miscellaneous Warranty Services that will be offered to County customers pursuant to this arrangement.

## 4.2 PROGRAM IMPLEMENTATION AND ADMINISTRATION

The Selected Service Provider will be expected to manage program implementation and all phases of program administration including customer requests, enrollment, dispatching contractors, billing, service repairs, customer complaints and service cancellation. The service provider should vet the subcontractors and is responsible for their work. The Service Provider must provide a copy of its customer dispute resolution policy/procedures. The county has the option to review disputed complaints and reserves the option to compel the Provider to make necessary repairs. The provider must be willing to appoint an employee as the key contact/representative for the contract. The appointed contact will be responsible for regular reporting of Program milestones, performance metrics, and address inquiries or concerns the county may have.

#### 4.3 CUSTOMER SATISFACTION

The Provider will supply a toll-free customer service telephone number that is available 24 hours a day, 365 days per year, with live, stateside staff for all residential customer claims/requests for service, customer inquiries, application for service and customer billing, and complaints. The provider will be required to guarantee response time, including schedule of replacement or repair with residential customer and repair subcontractor within 24 hours. The provider will enable residential customers to enroll or cancel at any time. The provider must cease all marketing efforts to customers who choose not to be contacted.

#### 4.4 MARKETING

It is expected that the Provider will execute a marketing plan that is directed at all eligible customers. The provider will incur costs for all marketing design, production and mailing costs for brochures, flyers, press releases, and other marketing needs. All marketing materials and strategy must be pre-approved by Union County. The provider may use customer data, names and addresses supplied by the County to assist in marketing efforts. The provider may use Union County's logo for co-branding and marketing purposes. The provider must obtain approval for all marketing materials that contain the Union County logo prior to distribution. Provider should make best efforts to publish marketing materials in Spanish and English. The provider must also have an option for customers to opt out of marketing efforts at any time and for any reason.

# 5 DETAILED SUBMITTAL REQUIREMENTS AND INSTRUCTIONS

## 5.1 TERMS OF SUBMISSION

All material received from a person or company ("Respondent") in response to this solicitation shall become the property of Union County and will not be returned to the Respondent. Any and all costs incurred by a Respondent in preparing, submitting, or presenting submissions are the Respondent's sole responsibility and Union County shall not reimburse the Respondent. All responses to this solicitation will be considered a public record and subject to disclosure under applicable public records law.

Any material in a response which the Respondent considers a trade secret and exempt from disclosure as a public record under applicable law, including N.C.G.S. §§ 132-1.2 and 66-152, must be properly designated as a trade secret. In order to properly designate such material, the Respondent must: (i) submit any trade secret materials in a separate envelope, or file, from all other submitted material, being clearly marked as "Trade Secret – Confidential and Proprietary Information," and (ii) stamp the same trade secret/confidentiality designation on each page of the materials therein which contain trade secrets.

To the extent consistent with public records law, Union County will make reasonable efforts to maintain the confidential nature of trade secrets, as determined by Union County and subject to the conditions set forth herein. Respondent understands and agrees by submitting a response to this solicitation, that if a request is made to review or produce a copy of any information in the Respondent's materials which was properly labeled by the Respondent as a trade secret, Union County will notify the Respondent of the request and the date that such materials will be released to the requestor unless the Respondent obtains a court order enjoining that disclosure. If the Respondent fails to obtain the court order enjoining disclosure prior to that date, Respondent understands and agrees that Union County will release the requested information to the requestor on that date.

Furthermore, the Respondent also agrees to indemnify and hold harmless Union County and each of its officers, employees, and agents from all costs, damages, and expenses incurred in connection with refusing to disclose any material that has been designated as a trade secret by Respondent.

## 5.2 DUPLICATE PROPOSALS

No more than one (1) proposal from any Offeror will be considered by the County. In the event multiple proposals are submitted in violation of this provision, the County will have the right to determine which proposal will be considered, or at its sole option, reject all such multiple proposals.

#### 5.3 PROPOSAL FORMAT

<u>The County desires all responses to be identical in format.</u> While the County's format may represent a departure from the vendor's preference, the County requests adherence to the format. All responses are to be in the format described below.

Offerors should prepare their proposals in accordance with the instructions outlined in this section. Each Offeror is required to submit the proposal electronically – Refer to page 4, 2.2. Each section should be identified as described below. Proposals should be prepared as simply as possible and provide a straightforward, concise description of the proposer's capabilities to satisfy the requirements of the RFP.

The County may award a contract based on initial offers received without discussion of such offers. A proposer's initial offer should, therefore, be based on the most favorable terms available. The County reserves the right to contact proposers regarding cost and scope clarification at any time throughout the selection process.

The successful Offeror's proposal must include all responses to the requirements contained within this RFP and all appendices (if applicable) must be completed in their entirety.

By submitting a proposal, the successful Offeror's Offeror agrees to all applicable provisions, terms and conditions associated with this RFP. This solicitation, the successful bidder's submitted proposal, all appendices and attachments (if applicable), and stated terms and conditions may become part of the resulting contract.

Utmost attention should be given to accuracy, completeness, and clarity of content. All parts, pages, figures, or tables should be numbered and clearly labeled. Response information should be limited to pertinent information only. Marketing and sales type information is not to be included.

#### 5.4 SELECTION PARTICIPANTS

- 1. Maintaining the integrity of the RFP process is of paramount importance for the County. To this end, please do not contact any members of Union County or its staff regarding the subject matter of this RFP until a selection has been made, other than the County's designated contact person identified in the introduction to this RFP.
- 2. Representatives of Union County will read, review, and evaluate the RFP independently based on the evaluation criteria. Failure to abide by this requirement shall be grounds for disqualification from this selection process.
- 3. The County will establish an RFP Evaluation Team to review and evaluate the RFPs. The RFP Evaluation Team will assess the RFPs independently in accordance with the published evaluation criteria. Union County reserves the right to conduct interviews with a shortlist of selected respondents.
- 4. At its sole discretion, the Owner may ask written questions of Offerors, seek written clarification, and conduct discussions with Offerors on the RFPs.
- 5. The County reserves the right to determine the suitability of proposals on the basis of a proposal meeting scope and submittal criteria listed in the RFP. Evaluation criteria and other relevant RFP information will be used to assist in determining the finalist Vendor.

## 5.5 EVALUATION SELECTION PROCESS

A weighted analysis of the evaluation criteria will be utilized to determine the Vendor that represents the best value solution for the County.

In the evaluation and scoring/ranking of Offerors, the County will consider the information submitted in the RFP as well as the meetings (if applicable) with respect to the evaluation criteria set forth in the RFP.

The initial evaluation criteria/factors and relative weights listed below will be used to recommend selection of the Proposed Offeror or for the purpose of selecting Short-Listed Offerors. The County may choose to award without engaging in interview discussions.

Vendors may be invited to give a demonstration of the capabilities of the proposed solution to the Union County evaluation team. The successful bidder's demonstration (if requested), along with questions and answers, will be a critical component of the overall vendor evaluation. After identification of Short-Listed Offerors, the County may or may not decide to invite Short-Listed Offerors to vendor demonstration/interviews. If interviews are scheduled with the Short-Listed Offerors, previous evaluation and rankings are not carried forward. For the purpose of selecting a Preferred Offeror, the evaluation criteria will be given the following relative weights:

Additional meetings may be held to clarify issues or to address comments, as deemed appropriate. Proposers will be notified in advance of the time and format of such meetings.

## 5.6 AWARD PROCEDURE

Union County has the right to reject any or all proposals, to engage in further negotiations with any Company submitting a proposal, and/or to request additional information or clarification. The County is not obligated to accept the lowest cost proposal. The County may accept the proposal that best serves its needs, as determined by County officials in their sole discretion.

The County reserves the right to make an award without further discussion of the proposals received. Therefore, it is important that the proposal be submitted initially on the most favorable terms.

A proposal may be rejected if it is incomplete. Union County may reject any or all proposals and may waive any immaterial deviation in a proposal.

More than one proposal from an individual, Offeror, partnership, corporation or association under the same or different names, will not be considered.

The County reserves the right to enter into negotiations with the top ranked Offeror. However, negotiations with the top ranked Offeror does not signify a commitment by Union County to execute a contract or to continue discussions.

The County reserves the right to terminate negotiations at any time and for any reason. The County may select and enter into negotiations with the next most advantageous Proposer if negotiations with the initially chosen Proposer are not successful.

The award shall be made in the best interest of the County. This Request for Proposal is not subject to any competitive bidding requirements of North Carolina law. The County reserves the right to accept other than the most financially advantageous proposal. The award document will be a Contract incorporating, by reference, all the requirements, terms and conditions of the solicitation and the Offeror's proposal as negotiated.

## 5.7 CONFLICT CERTIFICATION

The Offeror must certify that it does not have any actual or potential conflicts of interest with, or adversarial litigation against the County or any of its officers or employees. During the course of the contractual relationship formed pursuant to this solicitation, any such conflict of interest, whether newly arising or newly discovered, must be disclosed to the County in writing.

# 6 GENERAL CONDITIONS AND REQUIREMENTS

## 6.1 TERMS AND CONDITIONS

The contract award will have an initial term of one (1) year with three (3) one-year renewal options at the County's discretion, pending annual budget approval.

Union County has the right to reject any or all proposals, to engage in further negotiations with any Company submitting a proposal, and/or to request additional information or clarification. The County is not obligated to accept the lowest cost proposal. The County may accept that proposal that best serves its needs, as determined by County officials in their sole discretion.

All payroll taxes, liability and worker's compensation are the sole responsibility of the Offeror. The Offeror understands that an employer/employee relationship does not exist under this contract.

All proposals submitted in response to this request shall become the property of Union County and as such, may be subject to public review.

## 6.2 CONTRACTUAL OBLIGATIONS

The contents of this Proposal and the commitments set forth in the selected Proposal(s) shall be considered contractual obligations, if a contract ensues. Failure to accept these obligations may result in cancellation of the award. All legally required terms and conditions shall be incorporated into final contract agreements with the selected Service Provider(s).

## 6.3 SUB-CONTRACTOR/PARTNER DISCLOSURE

If the proposal by any Company requires the use of sub-contractors, partners, and/or thirdparty products or services, this must be clearly stated in the proposal. The Company submitting the proposal shall remain solely responsible for the performance of all work, including work that is done by sub-contractors.

## 6.4 EXCEPTION TO THE PROPOSAL

An "exception" is defined as the Service Provider's inability or unwillingness to meet a term, condition, specification, or requirement in the manner specified in the Proposal. All exceptions taken must be identified and explained in writing in the proposal and must

specifically reference the relevant section(s) of this Proposal. Other than exceptions that are stated in compliance with this Section, each proposal shall be deemed to agree to comply with all terms, conditions, specifications, and requirements of this Proposal. If the Service Provider provides an alternate solution when taking an exception to a requirement, the benefits of this alternate solution and impact, if any, on any part of the remainder of the Service Provider's solution, must be described in detail.

#### 6.5 MODIFICATION OR WITHDRAWAL OF PROPOSAL

Prior to the scheduled closing time for receiving proposals, any Vendor may withdraw their proposal. After the scheduled closing time for receiving proposals, no proposal may be withdrawn for 180 days. Only written requests for the modification or correction of a previously submitted proposal that are addressed in the same manner as proposals and are received by the County prior to the closing time for receiving proposals will be accepted. The proposal will be corrected in accordance with such written requests, provided that any such written request is in a sealed envelope that is plainly marked "Modification of Proposal" – with solicitation number and name on the front of the envelope. Oral, telephone, or fax modifications or corrections will not be recognized or considered.

## 6.6 EQUAL EMPLOYMENT OPPORTUNITY

All Offerors will be required to follow Federal Equal Employment Opportunity (EEO) policies. Union County will affirmatively assure that on any project constructed pursuant to this advertisement, equal employment opportunity will be offered to all persons without regard to race, color, creed, religion, national origin, sex, and marital status, status with regard to public assistance, membership or activity in a local commission, disability, sexual orientation, or age.

#### 6.7 MINORITY BUSINESSES (MBE) OR DISADVANTAGED BUSINESSES (DBE)

It is the policy of Union County that Minority Businesses (MBEs), Disadvantaged Business Enterprises (DBEs) and other small businesses shall have the opportunity to compete fairly in contracts financed in whole or in part with public funds. Consistent with this policy, Union County will not allow any person or business to be excluded from participation in, denied the benefits of, or otherwise be discriminated against in connection with the award and performance of any contract because of sex, race, religion, or national origin.

## 6.8 LICENSES

The successful Offeror(s) shall have and maintain a valid and appropriate business license (if applicable), meet all local, state, and federal codes, and have current all required local, state, and federal licenses.

## 6.9 E-VERIFY

E-Verify is the federal program operated by the United States Department of Homeland Security and other federal agencies, or any successor or equivalent program, used to verify the work authorization of newly hired employees pursuant to federal law. Vendor/Offeror shall ensure that Offeror and any Sub-Contractor performing work under this contract: (i) uses E-Verify if required to do so; and (ii) otherwise complies with applicable law.

## 6.10 DRUG-FREE WORKPLACE

During the performance of this Request, the Offeror agrees to provide a drug-free workplace for their employees; post in conspicuous places, available to employees and applicants for employment, a statement notifying employees that the unlawful manufacture, sale, distribution, dispensation, possession, or use of a controlled substance or marijuana is prohibited in the workplace and specify the actions that will be taken against employees for violations of such prohibition; and state in all solicitations or advertisements for employees placed by or on behalf of the Offeror that the Offeror maintains a drug-free workplace.

For the purposes of this section, "drug-free workplace" means a site for the performance of work done in connection with a specific contract awarded to an Offeror/Offerors in accordance with this chapter, the employees of whom are prohibited from engaging in the unlawful manufacture, sale, distribution, dispensation, possession or use of any controlled substance or marijuana during the performance of the Request.

## 6.11 INSURANCE

One or more of the following insurance limits may be required if it is applicable to the project. The County reserves the right to require additional insurance depending on the nature of the agreement.
