2. Please provide the number of occupants in each group that is moving related to this project. (i.e. tax group moving from 2<sup>nd</sup> to 4, 5, and 6; DA's moving from the Judicial Center to the 2<sup>nd</sup> floor of the government center).

Answer: Floors 4, 5, & 6 will be designed to accommodate 72 persons. The DA relocation to floor 2 of the government center will be able to accommodate 33 staff members.
